Module 1. International grants and research projects

1. Online lectures – 10 hours:
 - Financial streams for researchers in the field of medicine from EU funds, non-governmental organizations, foundations, enterprises;
 - Rules for applying for grants common to all sources of financing, including: budget structure, research stages, settlements of researchers with research results;
 - International research projects carried out in research groups. The specificity of constructing international projects;
 - Sources of information about grant contests in medicine.
2. Consultations - 2 hours
3. Preparation and individual work - 12 hours
4. Work on individual projects - 6 hours

Module 2. Forms of internationalization of universities in Europe.

1. Online lectures – 10 hours:
 - Program Erasmus+: Why is it worth? The principles of the Program's operation, the rules for participation in the Program of countries from outside the EU;
 - National Agency for Academic Exchange, or policy of cooperation with the Member States (the Republic of Poland and for foreigners);
 - The importance of internationalization at universities in Poland: building internationalization strategies, internationalization rankings, examples of good practices in the field of acquiring foreign partners;
 - The Bologna Process and the higher education system in Europe;
 - Innovations and information technologies the future of modern education of doctors.
2. Consultations - 2 hours
3. Preparation and individual work - 12 hours
4. Work on individual projects - 6 hours

Module 3. Paths of educating doctors in the Polish and European system of training specialists

1. Online lectures – 10 hours:
 - Medical studies in selected European countries;
 - Training of doctors and dentists in Poland – uniform masters studies;
 - Specializations of doctors and dentists - regulations, organization;
 - The role of CMKP in the system of specialist training for doctors and dentists;
 - Medical associations (medical boards), non-governmental organizations and their role in the medical profession.

Module 4. Study visits

1. A visit to the rectorate of the Medical University of Lublin - presentation of the university – 2 hours
2. Evaluation of training participants (test) - 2 hours

4. A visit to the Medical Simulation Center – 6 hours
